Note: During the Quarter ended December 31, 2020, the Company on December 31, 2020, subject to requisite approvals, made an allotment of 154,639,175 unlisted, fully-paid, 0.01% Compulsorily Convertible Preference Shares ('CCPS') of face value of Re. 1/- each, at an issue price of Rs 5.82/- per CCPS (including premium of Rs 4.82/- per CCPS), which is subject to lock in for a period of 1 year till Dec 31, 2021. Each CCPS is convertible into Equity shares on a 1:1 basis, within a period of 18 months from the date of allotment. The said allotment is done under Preferential Issue (Private Placement Basis) to only one investor namely Miloex Media & Entertainment Private Limited. During the quarter ended June 30, 2021, the investor has not exercised conversion of any CCPS into equity share of the Company.
